Whereas I, **Shri Anjani Kumar Mishra, IAS (Retd.)**, have been appointed by Hockey India as the **Electoral Officer** to conduct the election of the Office Bearers and Members of the Executive Committee of Hockey Jharkhand;

Now, therefore, in exercise of the powers conferred under the Bye-laws and the Election Rules of Hockey Jharkhand, I hereby call the election of the Office Bearers and Members of the Executive Committee of Hockey Jharkhand for the term **2026–2030**.

- c) Secretary General - One
- d) Joint Secretary(ies) – Two
- e) Treasurer – One
- f) Executive Committee Members – Three

4. Nominations

The nomination of a candidate for election shall be proposed and seconded by the persons whose name appears on the electoral roll.

Nomination papers shall:

- be submitted personally by the candidate;
- be duly proposed and seconded by eligible electors;
- reach the Electoral Officer within the prescribed time and date at the venue mentioned above; and
- comply with the provisions of the Bye-laws and the Election Rules of Hockey Jharkhand.

5. Final Electoral Roll

The **Final Electoral Roll** is published simultaneously with this Notification. Only persons whose names appear therein shall be entitled to propose, second, and vote in the election.

6. Poll

Where the number of validly nominated candidates exceeds the number of vacancies for any post, polling shall be conducted by **secret ballot**.

7. General Instructions

- a) Candidates shall strictly adhere to the Election Rules and Code of Conduct.
- b) Canvassing or campaigning contrary to the Election Rules is prohibited.
- c) The decision of the Electoral Officer on all procedural matters arising during the election shall be final, subject to the provisions of the Act, the Rules and the Bye-laws.
